Corporate Fleet Eco and Safety Policy

1. Introduction

2. Commitment to Fleet Eco and Safety Practices

- e. Setting Objectives and Monitoring Performance: We set annual and long-term environmental and safety objectives for our fleet operations, aligned with Company goals. We regularly assess and monitor performance and take necessary actions to ensure continuous improvement.
- **f. Fuel Efficiency and Emission Reduction:** We implement measures to improve fuel efficiency and reduce emissions, such as optimizing route planning, reducing idling times and using advanced telematics to monitor and manage vehicle performance.
- g. Zero Tolerance for Impaired Driving: The consumption of substances that impair driving ability is strictly prohibited while operating Company vehicles.
- **h.** Use of Mobile Devices: Employees must not use mobile devices without hands-free capabilities while driving. Urgent communication should be addressed in a safe location.
- i. **Risk Management:** We proactively identify, assess and manage risks associated with our fleet operations. This includes conducting regular risk assessments, implementing control measures and continuously monitoring potential hazards.
- j. Emergency Preparedness and Response: We prepare and maintain emergency response plans to effectively manage incidents and emergencies involving our fleet. This includes conducting regular drills and ensuring that all drivers are familiar with emergency procedures.

- **Training and Competence:** We provide continuous training programs to ensure that all drivers and employees that drive Company vehicles are knowledgeable about driving eco-friendly and safe practices.
- Fuel Management: We implement programs to monitor and manage fuel consumption and emissions.
- Incident Reporting and Investigation: We establish procedures for reporting and investigating incidents, accidents and near-misses to prevent recurrence.
- Audits and Reviews: We perform regular audits and reviews of our fleet operations and contractors to identify areas for improvement and ensure compliance with our management systems.

5. Reporting and Accountability

We commit to transparency in our fleet eco and safety practices by regularly reporting on our performance and progress. We hold ourselves accountable to our stakeholders through continuous monitoring, evaluation and improvement of our fleet's environmental and safety performance.
